# TOWN OF CEDARBURG APPLICATION FOR PERMIT TO DISPLAY FIREWORKS

**Contact staff early to ensure the Town Chairman or Administrator will be able to consider the application so you do not miss your intended display date.**

1. As stated in Town Code Chapter 158 and Wis. Stat. §.167.10(3)(c), the following may obtain a permit: public authority, fair association, amusement park, park board, civic organization, individual or group of resident or nonresident individuals, and agricultural producer for the protection of crops from birds or animals.
2. Fire extinguishers are required on the premises; smoking is prohibited.
3. Long-term storage of fireworks requires that they be located at least 500 feet from a dwelling, public assemblage or place where gasoline or other volatile liquids are sold, and that the Fire Chief be notified of the storage location.
4. Parents are liable for damages caused by minors.
5. Neighbors should be notified.
6. **A certificate of insurance for bodily injury and property damage in the amount of one million dollars must be submitted before a permit will be issued; the Town of Cedarburg must be listed as an insured on the policy.**
7. The following penalties are enforced through Wis. Stat. §.167:
  - A person who possesses or uses fireworks without a valid permit, or who sells fireworks to a person who does not have a valid permit, is subject to a forfeiture of up to \$1,000 per violation
  - A parent or guardian who allows a minor to possess or use fireworks (not including those for which no permits are required) is subject to a forfeiture or up to \$1,000 per violation
  - A city, village or **town** may obtain an injunction prohibiting a person from violating of Wis. Stat. §.167.10(8)(a). Violations of such an injunction are criminal misdemeanors, subject to up to 9 months in jail and a \$10,000 fine.
